Size of Loans



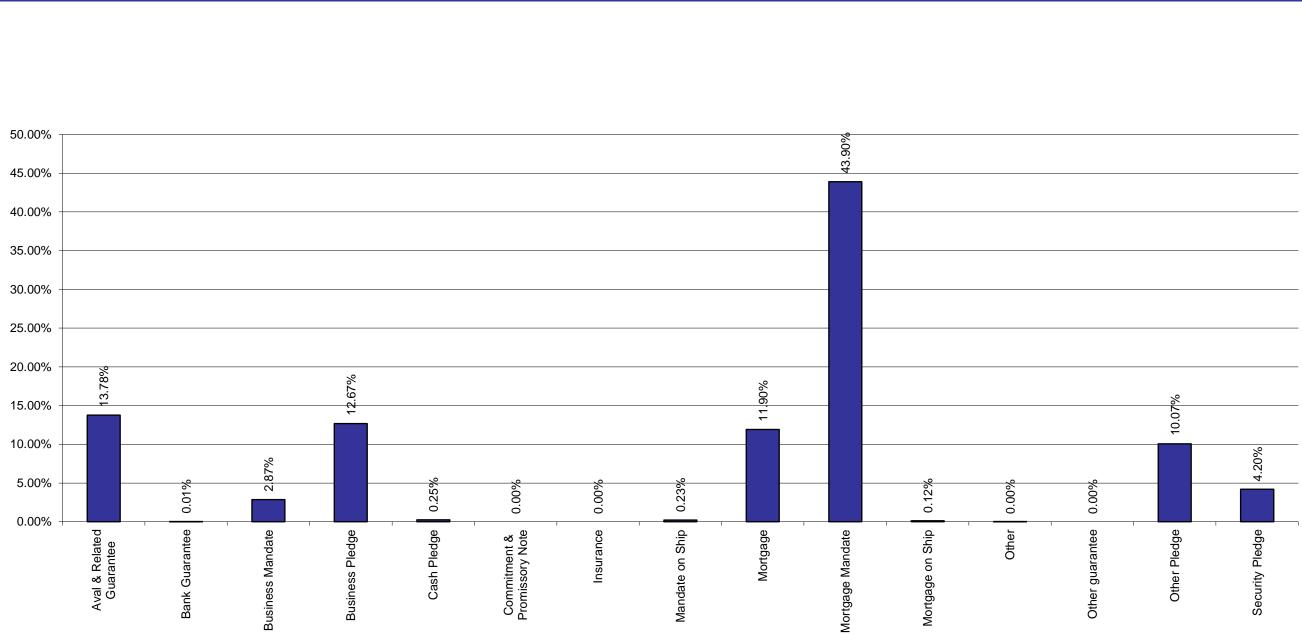

Collateral Ratio

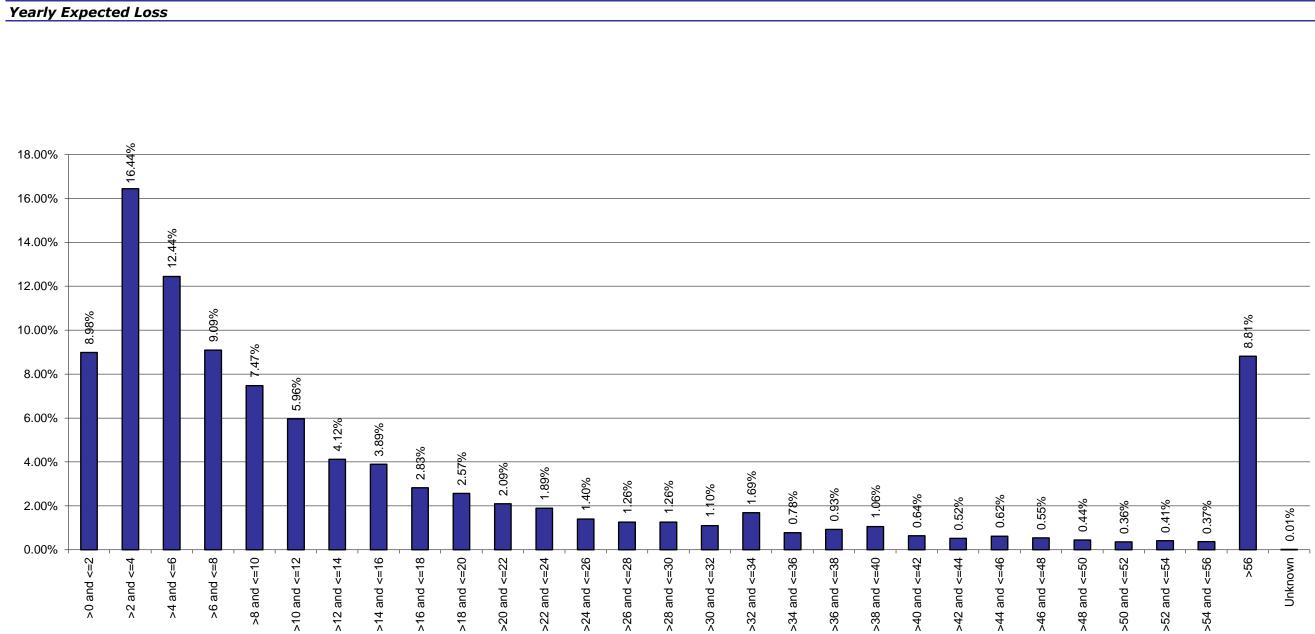
